#### JOB SUMMARY

Ensure that all parks and playgrounds are maintained. Ensures that all agency grounds and outdoor facilities are kept clean, safe, pest-free and attractive.

#### **ESSENTIAL DUTIES**

- Ensure the cleanliness of all agency facilities and property
- Create an inspiring experience for all agency customers
- Ensure game readiness of all athletic fields, including proper layout, game-appropriate grounds maintenance and lining
- Ensure the immediate correction of outdoor safety hazards
- Apply pesticide and herbicide treatments
- Ensure all plants are pruned, trimmed, and healthy
- Ensure clean-up of grounds and outdoor facilities after severe weather events
- Act to ensure the safety and well-being of participants using agency facilities

## **OTHER DUTIES**

- Inspect and maintain playground equipment to ensure compliance with safety standards
- Inspect fields prior to games to ensure readiness
- May occasionally be requested to work evenings or weekends for special events
- Other duties as assigned
- Must have dependable transportation

#### WORKING CONDITIONS

The majority of work takes place during the hours of 6:00 am to 3:00 pm, Monday through Friday.. Work is divided between agency grounds and the maintenance shop, a one-story building containing one large office, a double garage bay, and repair and storage areas. The parks maintenance office can be entered through the building interior. Must be physically able to operate a variety of equipment including mechanics tools, carpenters tools, electrical tools, plumbing tools, shovels, rakes, etc. Tasks involve the

regular and at times sustained performance of moderately physically demanding work, typically involving some combination of climbing, balancing, stooping, kneeling, crouching and crawling, and the lifting, carrying, pushing and/or pulling of moderately heavy objects and materials (up to 50 pounds) and occasionally heavier weight (up to 100 pounds) with assistance. Outdoor conditions may include bright direct sunlight and temperatures may range from 40\*F to 100\*F
